**ORDINANCE NO. 2022-03**

**AN ORDINANCE ADOPTING A REVISED CODE OF ORDINANCES FOR THE VILLAGE OF HOFFMAN, CLINTON COUNTY, ILLINOIS.**

**WHEREAS**, the Village of Hoffman, Illinois is an Illinois non-home rule municipal corporation pursuant to Article VII, § 8 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

**WHEREAS**, the corporate authorities of each municipality may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines and penalties as may be deemed proper. 65 ILCS 5/1-2-1; and

**BE IT ORDAINED BY THE MAYOR AND THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF HOFFMAN, CLINTON COUNTY, ILLINOIS, THAT:**

**SECTION 1: Adoption.** There is hereby adopted a "Revised Code of Ordinances" for the Village of Hoffman, Clinton County, Illinois shall be as follows:

**SECTION 2: Severability of Provisions.** Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.

**SECTION 3: Conflicting Ordinances.** Any conflicting ordinances, code provisions or pertinent portions thereof in effect at the time this ordinance takes effect are hereby repealed.

**SECTION 4: Effective.** This Ordinance shall be in full force and effect ten (10) days from and after its passage, approval, and publication in pamphlet form as provided by law.

**SECTION 5:** Passed this 12<sup>th</sup> day of October, 2022 by the Village Board of Trustees of the Village of Hoffman, Clinton County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
